Biographical Note

Paul Anthony Costo, Jr. and Jean Lee Robison Costo (1939 – April 28, 2021) both graduated from Indiana State College in 1960. Jean Lee Robison Costo was the daughter of Evelyn Mae Heverly Robison (April 23, 1909 – October 23, 2002) who graduated from Indiana State Normal School (ISNS) in 1927 and Indiana State Teachers College (ISTC) in 1930, and her father was Joseph Edward Robison (January 5, 1906 – March 23, 1985) who graduated from the University of Pittsburgh. The collection also includes information about Paul Anthony Costo, Sr., who was a brakeman and conductor at the Railroad Yard in Cherry Tree, Indiana County, Pennsylvania.

Scope and Content Note

This collection contains correspondence, memorabilia, and publications that belonged to Evelyn Mae Heverly Robison (Class of 1927 and 1930), Paul Anthony Costo, Jr. and Jean Lee Robison Costo (Class of 1960).
